

I hereby certify that the following special resolution was passed at a meeting of the members of BRIDLE ESTATES HOMEOWNERS' ASSOCIATION, corporate access number: 5111838271, on May 30, 2016.

The Articles of Association changes number 33 of its articles to read as follows:

At each Annual General Meeting of the Association, all Directors, howsoever appointed or elected, whose term has expired, shall retire from office and the Association shall elect new Directors as required. A Director shall be elected at an Annual General Meeting for a term expiring in the second (2nd) year following the year in which he/she is elected to Board of Directors. A retiring Director shall retain office until the dissolution of the meeting at which his/her successor is elected. If at any Annual General Meeting at which an election ought to take place, no such election takes place, the retiring Directors shall continue in office until the Annual General meeting in the next year, and so on year to year until places are filled, unless it shall be determined at such meeting to reduce the number of Directors.
